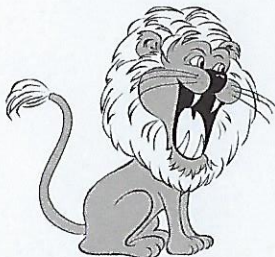
How Does the Tax Credit

Enacted in 1997, an Arizona law that allows taxpayers a direct tax credit!

A credit is allowed against the taxes imposed by this title for the amount of any fees or cash contributions paid by a taxpayer during the taxable year to a public school located in the state for the support of extracurricular activity programs but not exceeding \$200 for an individual of single head of household, \$400 for married couple filing jointly.

“Extracurricular activities” means school-sponsored activities that require enrolled students to pay a fee in order to participate.

These activities are optional and/or supplement the regular education program offered at the school!



This is How the Tax Credit Works for YOU!

Here are a couple of examples:

#1: If you are due a refund:

AZ Tax withheld	\$1,000
Tax Liability	<u>\$800</u>
Normal Refund	\$200

If you Contribute \$400 to Tax Credit

AZ Tax withheld	\$1,000
Tax Liability	\$800
Tax Credit	<u>\$400</u> <small>Contributed to a school</small>
Tax Refund	\$600 !!!!!

#2: If you owe more money to the State:

AZ Tax withheld	\$1,000
Tax Liability	<u>\$1,400</u>
You Would Owe	\$400

HOWEVER, if you contribute to Tax Credit

AZ Tax withheld	\$1,000
Tax Liability	\$1,400
Tax Credit	<u>\$400</u> <small>Contributed to a school</small>
You Would Owe	\$0 !!!!!
